## Avis additional driver fee spouse uk

Yes, you can fill out additional driver forms to add additional drivers to your rental car. Additional drivers must be at least 25 years old and have a valid driver's license. You can add up to two drivers to your vehicle. The price is \$13 per day per additional driver in most U.S. states. The maximum driver fee for the rental period is \$65. In New York, the additional driver fee is \$3 per day for each additional driver. In Nevada, prices are \$11 per driver per day, with rates of up to \$65 per rental. There are no additional driver fees in California. Some additional drivers are always exempt from additional charges as long as they meet the basic requirements of Avis renters: they have a valid license and must be at least 25 years old. The following describes the most common additional drivers and how Avis policies apply to them. Spouse or Partner Spouse or life partner can drive a rental car at no extra cost as long as they have a valid driver's license and are 25 years of age or older. An employer or employee's boss or fellow employee can drive a rental car as an additional driver at no extra charge as long as they are on a business trip and have their current driver's license. All drivers must be at least 25 years old. If a renter on a rental contract with a disability cannot operate the rental car due to the disability, additional drivers can drive the vehicle without paying an additional driver fee. The primary renter must fill out the licensed renter form and the driver must present the license and be at least 25. Friends or Extended Family Members Additional driver fees apply to friends and extended family who want to drive a rental car as an additional driver. These drivers must fill out additional driver forms and must be at least 25 years old. After filling out the form, you will need to present a valid driver's license at the rental counter. How to add additional drivers If someone else rents a car to drive, the fee will apply, you need to make sure they fill out an additional driver form. We recommend that you fill out the return date as close to the return location as possible and display the receipt. If you don't return the vehicle with a full tank, or if you can't see the fuel receipt, you'll be charged. Jersey, Guernsey and the Isle of Man have a variety of fuel requirements. Yes, often the fuel gauge still looks full, so we fill up the tank near where we go back and show us a copy of the receipt. If you don't have time to fill up your tank or can't view receipts, apply EZ Fuel to cover the cost of refueling your vehicle. How much is EZ fuel? Depending on where you are renting, you pay a fixed fee of between €14.40 and €16.70 for the car and between €21.60 and €25.06 for the van. Pay the fuel based on the factory-installed fuel gauge and be truncated to the 1/8th (1/8) closest to the tank. It is based on the fuel tank capacity mentioned by the manufacturer. We charge between 1.5 and 3 times the average fuel price at the end of the UK rental period, as stated in this. The price per liter will be stated in the rental agreement. This fee covers our cost of driving to the nearest gas station immediately and potentially delaying the rental of the next customer. Let others drive? yes, but only if we approve of them.
